This is our first juried online exhibit! Submit artwork like what you would enter in the Power Center and Village Theater at Cherry Hill exhibits. Work you make for this show could end up in one of our physical exhibits once we beat this COVID thing.

### To be eligible to exhibit you must have:

- paid your 2021-2022 AAFG membership dues
- your work accepted by the exhibit jurors

### Eligible Work

- 2D and 3D fiber art of any size.
- Work may be composed of a single piece, or a composition of several smaller works constructed to hang as a unit. *Special Considerations: If work is small and presented as a group, a digital image showing the grouping must be submitted.*
- Work not shown previously at Cherry Hill or Power Center, work created within the past 5 years, and "key" pieces which are not stylistically "dated."

- For each submission, include a photo of your work, and a detail shot if possible.
- Include the title of your piece

### Digital Image Size Requirements:

- Sharp image(s).
- Minimum size: 1200 x 800 pixels
- JPEG format only.
- Send as an attachment or put in a zip folder.
- The name of the file should match the name of your piece and your last name. Example: chromacolor\_richter (chromacolor\_richter.jpeg) or ChromaColorRichter (ChromaColorRichter.jpeg)
- **FROM A SMARTPHONE.** If sending a photo from your phone camera, it is difficult to rename your file. So, include only **ONE IMAGE PER EMAIL**. Send the largest file possible (**ACTUAL SIZE IS PREFERRED but use at least HIGH**). You should be able to choose that setting when you send the email. Photos can always be reduced to the correct size but enlarging will distort the image.
